Because all the positions in our school require working in close sensitive contact with minors (children under the age of 18), we request your authorization for us to check references, driver's records, and criminal records. We realize this procedure, along with some of the "personal" questions we ask in this application, may seem threatening. Nevertheless, we have a moral and legal obligation to make all reasonable efforts to protect the children entrusted into our care. We assure you we will treat this information with high standards of confidentiality.

PHILOSOPHY

NCS adopts a historic, Christian view of life as presented in the Bible. The essence of this view is that life should be God-centered and glorify Him, since He, being the sovereign and holy God, created, owns and sustains everything through His Son, Jesus Christ. In His holiness and perfection, God desires a relationship with His creation, especially mankind.

Man chose to reject this relationship. Each individual is, by nature and choice, a sinner who can never in himself glorify and know God. Out of His immense love, God provided a way to redeem and regenerate mankind, restoring man to a right relationship with Himself. This is accomplished as an individual places his faith and trust in the saving work that Jesus Christ did for all on the cross.

NCS seeks to present all truth as interpreted by or revealed in God's Word. Our curriculum is taught from a Biblical Christian viewpoint, by born-again believers. We desire to help each student grow in wisdom, stature, and favor with God and man. We believe in the inerrancy of the Bible. We believe marriage is a lifelong covenant between one man and one woman, and that God bestows gender upon each person as male or female to reflect His image.

NCS recognizes that education is primarily the parents' responsibility. The school functions as an extension of the home in nurturing each student in a firm Biblical foundation.

LIFESTYLE POLICIES

Because Nebraska Christian Schools is dedicated to providing a Christian educational environment and propagating biblical Christianity, we expect all our employees to conduct themselves according to the high moral, ethical and behavioral standards taught in Scripture. These standards prescribe Christ-like behavior such as loving one another, obeying God's word, submitting to those in authority and practicing self-control (Rom. 12:9-13:7, Gal. 5:26, Col. 3:12-17). These standards also identify unacceptable conduct. While all unacceptable conduct cannot be listed here, some of the most obvious examples include stealing,

lying, use of profanity, sexual immorality, pornography, the use of illegal/illicit drugs, the abuse of alcohol or tobacco, occult involvement, and rebellion.

As part of our lifestyle policies, we expect our employees to be faithful participants in a local church and to have a consistent practice of personal prayer and Bible reading.
